

A Perfect Time for this Rep to Vent

The ave Americans lost sight of what's important? Are we paying more attention to "Desperate Housewives" than to the desperate people in our own country? I'm talking about the millions of Americans who are unemployed and under-employed with poor paying (Wal-Mart) jobs. Furthermore, don't forget about the 4.5 million of us, who live precariously without health insurance. These are the battles that we have to fight at home. Do you wonder why so many Americans are more tuned into "American Idol" than the American President? Do you find it repulsive? Last, but most important, lower costs appear to be the driving force of worldwide economics, and in particular the electronics industry. This article examines the effects on both reps and distributors.

Many Americans are out of work because their jobs have migrated overseas. Our national debt is spinning out of control. If we don't apply the brakes, many economists feel that it threatens the financial stability of future generations. And while we are having memorial services for our gallant servicemen fighting an arguably senseless war, how about mourning the job losses as well? Where are the values and priorities of our elected leaders? Please excuse my reference to the aforementioned television shows. Frankly, I'm not into reality TV, but American-based manufacturing may not survive as long as the "Survivor" series. Personally, I hope our political leaders see the light and redirect our nation's priorities. As an example, I believe that we should get out of Iraq and, more importantly, that we should never have gone there in the first place. Our country's security was never threatened and now it has been proven that Saddam never had WMD's.

DTAM Shift

Ten years ago I wrote an article for EDT stating that the future of electronic distribution never looked brighter. However, in the past decade much has changed and I would rephrase my statement by saying "the future of electronic distribution in Asia, especially China, has never looked brighter". Recently I have had conversations with some senior management of global distributors, who commented that they wouldn't be surprised if the DTAM for board level components was larger in China than in the U.S. – I am convinced that it is.

Industry Trends

According to the latest DTAM survey conducted by Budde Marketing, the numbers have slipped dramatically. As an example, the national DTAM in 2000 was \$24 billion and the 2001 results show a resounding drop of 40% to \$14 billion. Subsequently, Electronic News stated that 2002 closed at \$11 billion – it's been downhill ever since. As reps and distributors, we're being severely impacted. Is our country destined to lose its manufacturing base? Yes, if we do nothing and remain apathetic. But, on the other hand, you may subscribe to George W's mantra - "If it's good for big business, it's good for America". I say that's true for our

country's richest people, but hardly true for our middle and lower classes. Outsourcing and off-shoring – call it what you may – are driving millions (if they can afford the gas) to the unemployment lines and bread lines.

Fear of Outsourcing

Salespeople are driven not only by money, achievement and recognition, but by fear of failure as well. All of the aforementioned are great motivators, but another fear has entered the arena as well, and that's the fear of losing your job based on the spectre of outsourcing and off-shoring. This can happen to the most effective of salespeople and it can be totally outside of their control. But it's all a reflection of the radical economic changes taking place in our country in the name of cost cutting and higher profits.

Free Trade is Hurting U.S. Reps

You don't have to be an economist to understand that the more OEM's and CEM's outsource their manufacturing to off-shore sites, the worse it is for domestic-based reps. As a matter of

fact, it's also taking its toll on distributors who lack an off-shore sales presence. For reps it means a split commission at best, on the proviso that it can be tracked. For commodity product at major CEM's, this is often a monumental job.

This Administration's failed trade policies are costing us jobs – not creating them! Instead of recognizing the need to change direction, the President's forthcoming appointment of Rob Portman to be the next U.S. Trade Representative does not bode well. Portman has voted in favor of every major free trade agreement negotiated by the past two administrations. To top that off, Portman is from Ohio, which has lost more than 200,000 jobs over the past four years. Ohio also ranks among the top five states in unemployment and the lack of new job creation.

Huge Job Losses

By all accounts, the President and the Republican Congress promised 1.5 million new jobs by November 2004. Their effort is very much off course. More than 3 million private sector jobs have been lost since January 2001, the worst job creation record since President Herbert Hoover. Manufacturing, particularly in the electronic sector, is in a prolonged free fall. It represents one of the largest groups of unemployed. Not long ago, it was looked upon as being highly secure. Would I urge my son or daughter to pursue a career in electronic engineering - NOT ON A BET! ODM is being outsourced as well. At the rate our country is going, next year's Labor Day will hardly be a celebration. We can hail the achievements of America's men and women, but the real celebration will be taking place in the streets of Shenzen, Beijing, Bombay and Calcutta. Typically that would equate to 10 to 12 jobs created in Communist China and India for each jobless US worker.

Employment

If you think job creation has kicked in – think again. According to Ed Sperling, Editor-in-Chief of Electronic News, the U.S. government is touting the fact that new jobs are rolling in every month, but he states that job creation may never again reach the levels we previously enjoyed. Productivity is up and costs are down, meaning everyone is doing the work previously done

by two or three people. That means Americans are working harder, but have more secure positions – we hope. We've had enough Washington spin and double talk and now is the time to apply the brakes and hold on to what we have – PLEASE.

Millions Exhaust Benefits

Do you remember our President declaring "mission accomplished" when referring to the unprovoked war we declared on Iraq? Well, he's the same guy who declared "the recession has ended". Where – in China or India? Tell that to your unemployed friend, neighbor or family member. What's over is their unemployment benefits. Losing Pensions

The current Administration supports legislation to reduce health care benefits for 8 million workers by exempting health plans from state regulation and allowing the state to drop coverage on such items as mammograms. Health care costs continue to spiral out of control, as well as the associated insurance premiums. Short of socialized medicine, do you see any relief in sight? Let us not forget the expense of Eldercare – it's huge business.

Embracing Big Business

Aside from leaving our Mexican borders open to illegal immigrants, it is reported that our President refuses to support proposals to increase the minimum wage. Why? Doesn't he realize that it will soon be at its lowest real value in 50 years?

Budget Cutting
